Thank you again for your rigorous and insightful review of the MA Art and Environment programme proposal. The conditions of the report were very fair and the recommendations encouraging and supportive of the programme. The course coordinators have now completed the conditions and recommendations outlined by the panel.

Conditions

- **Condition 1. (pages 1 – 37)** The programme document has been proofed for accuracy and consistency throughout.
- **Condition 2. (PD: pages 4 – 7 / SH: pages 8 - 9)** The programme document and the student handbook now reflect the current TU Dublin academic calendar.

Recommendations

- **Recommendation 1. (pages 11 – 37)** The course coordinators were highly appreciative of the framework suggested by the panel in the strong recommendations and have developed a twenty-six-page outline clarifying the intellectual framework for the programme:
 - **Programme Philosophy** (Archipelagic Thinking)
 - **Conceptual Grammar** (Socially Engaged Art)
 - **Object of Study** (Environment)
 - **Pedagogical Framework** (World-centered)
- **Recommendation 2. (pages 15 – 18)** the programme document explicitly outlines how the ‘environment’ will underpin the object of study.
- **Recommendation 3. (pages 4 – 7, continuous)** The Student Handbook explicitly outlines how the ‘environment’ will underpin the object of study.
- **Recommendation 4. (pages 22 – 37)** The module learning outcomes, indicative syllabus and reading lists have been revised to reflect the breadth and depth of learning that students will be expected to achieve on completion of each module.
