3.1.8 **Entry Requirements:** The aim is to offer bespoke programmes, designed through Learning Agreements to facilitate the participation of non-traditional students on a specified and limited number of industry-focused modules on the BA (Hons) Creative Digital Media.

Candidate eligibility will be assessed based upon educational attainment to date <u>and</u> an interview to assess suitability of the programme and availability of infrastructural resources to meet their needs.

Where a student begins at Level 6 (Certificate in Video/Multimedia) they must achieve a minimum Pass grade (C or better) in all modules in the Award year if they wish to advance to Level 7. Entry to Level 8 on this programme is subject to the same requirement in order to ensure the student is deemed capable of achieving more advanced Learning Outcomes.

3.1 INTRODUCTION

The panel was welcomed to the Institute by Glenn Mehta, Head of Department. The panel used the external review template as per the Quality Assurance Manual to assist in their deliberations.
