Irish Accounting and Finance Association (IAFA) 2025 Chairperson

Stuart Henderson is Chair of the Irish Accounting and Finance Association and Senior Lecturer in the Department of Accounting, Finance and Economics at Ulster University. His research focuses on socio-economic development – especially its inclusionary/exclusionary dynamics – in areas from finance to agriculture and social policy. His recent work includes exploring how "multiple insecurities" affect wellbeing and place-based inequalities, and various perspectives on enabling sustainable transitions in agriculture (e.g. succession, pro-environmental behavioural change, and enabling a just transition).

Christine Nangle is Head of the Discipline of Accounting at TU Dublin and a Chartered Accountant (FCA) with over 20 years teaching experience in Auditing and Financial Reporting. She is an executive committee member of the BAFA Auditing Special Interest Group, actively contributing to developments in audit research and education.





Professor Greg Stoner

Professor Greg Stoner is a leading researcher in accounting education, accounting education and technology, and accounting history. Based at the University of Glasgow, his research explores the evolution of accounting education and the accounting profession and the educational impact and utilisation of technologies in accounting practice and accounting in higher education.

Professor Greg Stoner has contributed significantly to advancing accounting education, for which he has recently been awarded the BAFA Outstanding Contribution to Accounting Education Award, and his paper "A critical review of Al in accounting education: Threat and opportunity" (Ballantine, Boyce and Stoner, 2024) is currently the most downloaded paper in Critical Perspectives on Accounting.



Professor Angela Pettinicchio

Angela Pettinicchio is Full Professor of Business Administration at Università Cattolica del Sacro Cuore and Affiliate Professor of Financial Reporting at SDA Bocconi School of Management. Angela currently serves as an Associate Editor of the International Journal of Auditing and is a member of the Editorial Boards of the European Accounting Review, Accounting in Europe, Accounting Forum, International Journal of Accounting, Auditing and Taxation, and the Journal of Management and Governance.

Angela is actively involved in the academic community as a member of the Management Committee of the European Accounting Association (EAA) and the Scientific Committee of EARNET (European Auditing Research Network). She also serves on both the Organizational and Scientific Committees for the EIASM Workshop on Audit Quality and has been part of the EAA Auditing Section's Scientific Committee since 2017.

Professor Martin Messner is a globally recognised management accounting and control scholar. Based at the University of Innsbruck, his research explores accountability, organisational decision-making, and the intersection of accounting with broader social and institutional structures.

Martin's work is frequently published in top-tier accounting journals, including the European Accounting Review; Accounting, Organizations and Society; or Contemporary Accounting Research. He has been an Editor-in-Chief of Accounting, Organizations and Society since 2021 and was Associate Editor of Management Accounting Research between 2015-2019. Martin has extensive experience mentoring early-career researchers. His keynote talk will address the question of what we mean when characterizing research papers as more or less "interesting" – interesting to whom, by which standards, and in which respect?
